**TULSA SAY NO TO HATE COALITION
URGES REJECTION OF SQ 755**

Tulsa, Oklahoma (September 1, 2010): The Tulsa Say No To Hate Coalition urges the rejection of State Question 755, the proposed Oklahoma International Law Amendment, that will appear on the November 2, 2010, general election ballot. SQ 755, a legislatively-referred constitutional amendment, would prohibit courts from using international law or Sharia law when deciding cases. Sharia law is Islamic law based on two principal sources: the Koran and the teaching of Mohammed.

Reference in SQ 755 to “international law,” does little to disguise the focus of the proposed ban: Sharia law. Oklahoma Representative Rex Duncan (R-Sand Springs), the chief author of SQ 755, has made that clear. Rep. Duncan called Sharia law a "cancer," and noted that "SQ 755 will constitute a pre-emptive strike against Sharia law coming to Oklahoma." He added: "While Oklahoma is still able to defend itself against this sort of hideous invasion, we should do so."

SQ 755 is both unwise and unnecessary. The measure simply fans the flames of bigotry against Muslims by suggesting, without evidence or justification, that Oklahomans somehow risk the rule of Islamic law. Supporters of SQ 755 have cited no case in which Sharia law has actually been applied in an Oklahoma court. The application of Sharia law by Oklahoma courts is a phantom threat, and SQ 755 is but a solution in search of a problem.

SQ 755 is a thinly-veiled attempt to drive a wedge between Oklahomans and Islam at a time when “Islamaphobia” has reached a fever pitch. Fear-mongering against Muslims, the practitioners of Islam, serves the interests of no one.

Here in Oklahoma, just as is the case all across the land, Muslims are our friends and neighbors; our doctors and lawyers; our teachers and classmates; our bosses and colleagues. We are one. We are Oklahomans. We are Americans.

Let your voices be heard: Oklahoma will not tolerate the bullying of its citizens, whether based on religion or any of the other dimensions of diversity that add richness to our State. Oklahomans have far more pressing issues with which to deal—a faltering economy; a lackluster public education system; and a struggling healthcare system, just to name a few. Let us marshal our collective resources around issues that really matter.

The Tulsa Say No To Hate Coalition urges Oklahomans to vote “**NO**” on SQ 755 on November 2nd. The defeat of this measure will be a victory for all Oklahomans.
